3. Subject of Public tender:

Electronic state volume converters (PTZ) II.

Subject of procurement is delivery of electronic state volume converters (PTZ) which meet the requirements of applicable legislation and technical standards, in quantities as required by Announcer upon terms agreed in framework purchase contract (hereinafter "Contract") and its amendments.

Subject of procurement is divided into three parts:

1st part - Electronic state volume converters (PTZ) with an external power supply and a backup battery - single-channel

2nd part - Electronic state volume converters (PTZ) with an external power supply and a backup battery - double-channel

3rd part - Electronic state volume converters (PTZ) battery converters - single-channel

Other terms of Tender, related to this subject including technical specification are provided in Tender documents.

4. Type of agreement to be concluded and other business terms and conditions:

Performance which is the subject of procurement, will be delivered on the basis of a framework purchase contract under § 409 et seq. Act no. 513/1991 Coll. Commercial Code, as amended, signed by representatives of both contracting parties.

Other business terms and conditions related to the subject of Tender including technical specification are provided in Tender documents.

5. Tender participation conditions:

In order to demonstrate ability to fulfil subject of Agreement, Bidder shall submit document about his business licence and other documents a papers that are mentioned in Tender documents.

Forming association in order to demonstrate ability of Bidder to perform subject of procurement is not allowed.

6. Submission of Bids:

Bidders submit Bids in Slovak or as a case may be in Czech language. Bidder may submit Bid in other foreign language but in this case, translation into Slovak language must be provided (official translation is not required).

Documentary part of Bidder's Bid and Price part of Bid (hereinafter "Price bid") of Bidder shall be submitted electronically, using portal http://spp-distribucia.proebiz.com (in accordance with requirements provided in invitation sent from this portal). Details are specified in the Tender documents.

7. Deadline for submission of Bids:

To January 20th, 2016 to 13:00 (CET)

8. Deadline for announcing selected Bid:

Deadline for announcing acceptance of Bid shall be 31.8.2016. Announcer reserves the right to extend such deadline.

9. Date and place of Bids assessment:

Period for Bids assessment shall begin by opening envelopes with Bids, i.e. **20.1.2016** and finished by announcing the accepted Bid and conclusion of Agreement. Bids assessment place is the registered office of Announcer (Mlynské nivy 44/b, 825 11 Bratislava).

10. Guarantee

Announcer does not require guarantee

11. The method for selecting the most appropriate Bid:

Announcer concludes Agreement with such Bidder, who fulfils all participation conditions including all conditions provided in Tender documents and on the basis of Bids assessment in accordance with criteria for Bids assessment provided in Tender documents submits the most economically advantageous Bid.

Announcer reserves the right to limit number of Bidders after submitting Bids and to invite this way selected Bidder to individual negotiations on conditions of Agreement or as a case me to participate in electronic auction.

Announcer reserves the right to negotiate with Bidder about Bids in some consequent phases with possibility to invite Bidders to submit updated Pride bid after each phase of negotiation. Announcer reserves the right to invite Bidders to update their Price bid in the form of electronic auction.
